

Enrollment Guidance for Hospice, Behavioral Health, and Home Health Agencies

Hospice

Enrollment requirements for Hospice providers can be found at 471 NAC 2 Provider Participation and 471 NAC 36 Hospice Services. Providers must comply with these regulations.

- There are commonly two types of Hospice enrollments: Hospices and Hospices in a Nursing Home
 - A Hospice will enroll with the following information:
 - Category: Facility
 - Provider Type: Hospice
 - Specialty: Hospice
 - Taxonomy: May vary
 - A Hospice in a Nursing Home will enroll with the following information:
 - Category: Facility
 - Provider Type: Nursing Home
 - Specialty: Hospice
 - Taxonomy: May vary

Behavioral Health Providers

Enrollment requirements for Behavioral Health providers can be found at 471 NAC 2 Provider Participation, 471 NAC 20 Psychiatric Services for Individuals Age 21 and Older, 471 NAC 32 Mental Health and Substance Abuse Treatment Services for Children and Adolescents, and 471 NAC 35 Rehabilitative Psychiatric Services. Providers must comply with these regulations.

- There are 9 behavioral health providers that can only be enrolled only as a Group Members of a Group Billing Provider
 - Category: Group Member Profile
 - Provider Type: Choose the appropriate provider type
 1. LDAC- Licensees Drug and Alcohol Counselor
 2. CSW- Community Support MRO Program
 3. CT/Peer Support- Mental Health Home Health Care Provider
 4. CTAI-Mental Health Personal Care Aid
 5. PDAC- Provisionally Licensed Drug & Alcohol Counselors
 6. SPHD- Specially Licensed PhD/Psychology Resident
 7. LMHP- Licensed Mental Health Practitioner/Masters Level Equivalent
 8. (P)MHP- Provisionally Licensed Mental Health Practitioner
 9. PPHD- Provisionally Licensed PHD-PPHD
 - Specialty: May Vary
 - Taxonomy: May Vary
 - Must be added to a Group Billing Provider as an Affiliated Individual Provider

- There are 2 behavioral health providers that can be enrolled in 3 different forms: (1) Group Members of an existing Group Billing Provider, (2) Individual/Solo Billing Provider, or (3) a Group/Institution Provider Type
 - Group Member
 - Category: Group Member Profile
 - Provider Type:
 1. LIMHP- Licensed Independent Mental Health Practitioner
 2. PHD- Licensed Psychologist
 - Specialty: May Vary
 - Taxonomy: May Vary
 - Must be affiliate with a Group Billing Provider
 - Individual/Solo Billing Provider
 - Category: Individual/Solo Provider
 - Provider Type:
 1. LIMHP- Licensed Independent Mental Health Practitioner
 2. PHD- Licensed Psychologist
 - Specialty: May Vary
 - Taxonomy: May Vary
 - Group/Institution Provider Type
 - Category: Group/Institution Provider Type
 - Provider Type:
 1. LIMHP- Licensed Independent Mental Health Practitioner
 2. PHD- Licensed Psychologist
 3. May also select Professional Clinic (PC) or another applicable Group Provider Type
 - Specialty: May Vary
 - Taxonomy: May Vary
 - Must also be an affiliated Group Members in the group

HHAG- Home Health Agency

Enrollment requirements for Home Health Agency providers can be found at 471 NAC 2 Provider Participation and 471 NAC 9 Home Health Agencies. Providers must comply with these regulations. To be enrolled as a Nebraska Medicaid provider, Home Health Agencies must be enrolled with Medicare or actively certified by an acceptable accreditation source (ACHC, CHAP, or TJC)

- Home Health Agencies are licensed agency providing home health care.
 - Home Health Agencies will enroll with the following information:
 - Category: Facility
 - Provider Type: Home Health Agency (HHAG)
 - Specialty: May Vary
 - Taxonomy: May vary

- Must be State licensed

Home Care companies that are not licensed and are enrolling as a Home and Community Based Service provider must first be referred by a Department Resource Developer or on one of the Waiver Service Coordination agencies (an Area Agency on Aging or the League of Human Dignity)
